Society also has under its umbrella two research institutions – one for Languages and social sciences and one for Environmental Engineering.

About Sarvajanik University

Sarvajanik University was established by the Sarvajanik Education Society, a 114 years old philanthropic educational trust in Surat that began as a small English medium school and gradually expanded and now comprises 33 educational institutions. Shri Chunilal Ghelabhai Shah founded the society with a vision to cater education to all. In 2021, Sarvajanik Education Society formally established Sarvajanik University under the Gujarat Private Universities Act.

Evolution through the 20th century

- Early expansion (1910s–1930s): After the Society’s registration, it launched collegiate education and Arts college came up in 1918, and Science teaching started in the late 1920s/1930s, which later developed into Sir P. T. Sarvajanik College of Science. Over the decades, the SES founded multiple colleges to meet Surat’s growing educational needs.
- Mid-late 20th century: The Society continued adding professional and technical institutes to serve the industrial needs of Surat city in the areas like textiles, chemicals, engineering. Notable later additions include Sarvajanik College of Engineering & Technology, established in 1995.

Transition to a University

Continuing its rich tradition of imparting education, the Sarvajanik Education Society established Sarvajanik University on 1st June 2021. Sarvajanik University is a recognised State Private University established under the Gujarat Private Universities Act and recognised by the UGC and AIU. The university brought several SES colleges/constituent institutes together under a single umbrella of a state private university while continuing the Society’s philanthropic governance and community focus.

2. Legal status and recognition (UGC, MHRD, State Government Act, etc.)

Establishment by State Act

- Sarvajanik University is a recognised State Private University established under the Gujarat Private Universities Act and recognised by the UGC and AIU. Regulatory Recognition (UGC)
- Sarvajanik University holds “UGC Recognition. Being recognised by UGC means the university is empowered under Section 22 of the UGC Act (1956) to award degrees. This is the standard legal requirement for universities in India.

Association of Indian Universities (AIU)

Sarvajanik University is a member of the AIU (Association of Indian Universities). Membership in AIU helps with the equivalence recognition of its degrees nationally and internationally.

Governing/Trust Body

The sponsoring body is the Sarvajanik Education Society (SES), which is registered under the Gujarat Public Trusts Act. In the Gujarat Private Universities (Amendment) Act, 2021.

Ordinances & Internal Governance

The First Ordinance of Sarvajanik University (August 2022) describes its governance structure (Academic Council, Board of Studies, etc.) under the framework laid out by the Private Universities Act. This ensures that the university has proper statutory governance aligned with Indian norms for private universities.

Institutional Collaborations, MoUs & Partnerships

Sarvajanik University has successfully done collaborations with international universities as well as local industries, design / engineering firms, through its constituent institutes.



The international MoUs will provide opportunities to abide the students and faculties for studying abroad, exchange programs, joint research and global exposure which will help in building a broader worldview and enhancing academic quality.



The strong industry-linkages (especially through its engineering, design, and management colleges) are likely intended to provide practical training, internship opportunities, and placement support — making curricular content more aligned with market/employer needs.



The strategic plan (2025–2030): Suggests the University is looking to increasingly integrate academia-industry-community, which could result in more collaborative research, real-world project work, and social engagement for students.

Industry & Professional Collaborations via Constituent Colleges

The “Collaborations and MoUs” list shows many tie-ups between the university’s constituent institutes (especially its design and engineering colleges) and industry/companies.

- Institute of Design, Planning & Technology - IDPT collaborates with many design/architecture/lighting/furniture / interior firms — e.g., “Sunshine Lights,” “Studio Conifur,” “Shipra Enterprise,” “SNS Asset Developers Pvt. Ltd.,” “AEON Devesya Design Associates,” “DWG Architects LLP,” etc. These cover areas like lighting, furniture design, architecture/interior design, building materials, urban design, etc.
- Sarvajani College of Engineering & Technology - SCET has MoUs with a variety of IT, engineering, textile, and manufacturing companies — including firms in software, instrumentation, textile, civil engineering, automation, solar, and more.
- For example SCET collaborates with companies such as “Hexxa GEO Systems Integrators Pvt. Ltd.,” “Gatisofttech, Surat,” “Energy Cloud Technology,” “Ultra Denim Pvt. Ltd.,” “Man Made Textile Research Association (MANTRA),” “Hema Automation,” etc.
- S. R. Luthra Institute of Management (SRLIM) has established collaborations with a range of organizations across diverse sectors such as digital marketing, healthcare, renewable energy, food processing, consulting, electronics, retail, and social development. These partnerships facilitate industry interaction, internships, live projects, and practical exposure for management students.
- For instance, SRLIM has collaborated with organizations such as Concept Medicals, Navitas Solar, Tapi Foods, Ajay’s Takeaway Foods Pvt. Ltd., Genmed Shoppe Pvt. Ltd., Decible Consultancy, Spark 99 Event Management, Unity Hospital, Shakti Foundation, Navin Electronics Pvt. Ltd., iVipanan Digital Marketing and Management Services, and BlissQuant, etc. These collaborations help strengthen industry-academia engagement and provide students with valuable exposure to real business environments.

These collaborations help support industry oriented education, internships, live project work, and placement linkages.



Institutional Strategy for Future Collaborations

In its “Institutional Development Plan (2025–2030),” Sarvajani University outlines its ambition to expand collaborations further.



Industry collaborations for curriculum development, internships/apprenticeships, joint projects that respond to evolving industry needs.



Academic and Research Collaborations Co-research projects, shared curricula, student/faculty mobility, dual-degree programmes, joint use of facilities, and even international joint research.



Community & Social Outreach Collaborations with NGOs and social-service organisations for rural outreach, community development, and societal engagement e.g., under government-backed programmes like Unnat Bharat Abhiyan.

Thus, the university considers institutional linkages as a core part of its mission.



Academic, Institutional & Student-Level Achievements (Under SU)



Third Convocation (2025): In February 2025, the University conducted its 3rd convocation, 1,318 students across 57 undergraduate, postgraduate and diploma programmes received their degrees.



Membership of National Digital Library of India: As of May 2025, the University became a member of the National Level Digital Library — a resource boost for students and researchers.



Research Infrastructure Strengthening (2025): The University procured statistical-analysis software (e.g. SPSS), subscribed to major research-methodology resources (e.g. SAGE Research Methods), indicating commitment to research quality.



“Earn While You Learn” Scheme: As of 2025, SU introduced a scheme to support financially needy students — giving them opportunities to work and learn, gain industry-relevant experience, and build employability.



Active Industry & Innovation Engagement: At the 2025 SGCCI Smart Education Expo & Surat Start-up Summit 2025, SU showcased student-led innovations — e.g. a Start-up product “MADDY” (a spirulina-based soft drink) — reflecting entrepreneurship and applied learning.

Community, Student-Life & Social Impact Highlights

- Community / Environmental Engagement On SU’s Foundation Day (1 June 2023), students and staff participated in a cleanliness drive at a local beach (as part of “Swachh Bharat Abhiyan”), showing social responsibility and community outreach.
- Holistic Education & Broad Curriculum Under SU The university emphasises inclusive, interdisciplinary and values-based education — integrating life skills, critical thinking, social responsibility, environmental awareness, and ethical professional values.
- Wide-Reach Education via SES Heritage Given SES’s longstanding presence (over 100 years) and its many institutions, SU inherits a legacy of broad educational outreach — schooling, colleges, professional and research institutes — making education accessible to many generations.

Ranking or Recognitions

- The university is approved by the University Grants Commission (UGC), All India Council for Technical Education (AICTE), Bar Council of India (BCI), and Council of Architecture (COA).
- It participates (i.e. submits data) in the National Institutional Ranking Framework (NIRF), the national ranking system managed by the Government of India / Ministry of Education / MHRD.

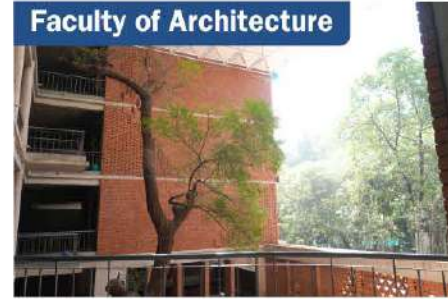

NCC at Sarvajanik University

National Cadet Corps of 6 Gujarat Girls BN NCC (Girls- Senior Wing), Surat is running at Shree Ramkrishna Institute of Computer Education and Applied Sciences, Sarvajanik University since 2019. NCC training institute aims to develop character, discipline, comradeship, a secular outlook, the spirit of adventure, and ideals of selfless service among Indian youth.

Four core training pillars

- Institutional Training:** Conducted at schools and colleges, this includes drill, weapon training (e.g., .22 rifle firing), map reading, and basic military history.
- Social Service & Community Development:** Activities like Swachh Bharat Abhiyan, blood donation drives, tree plantation, and disaster relief.
- Camp Training:** Practical residential training where cadets live a regimental life for 10–12 days.
- Adventure-Based Learning:** Activities such as mountaineering, trekking, parasailing, scuba diving, and camel safaris.

NCC Camps

- Major National and International Camps** are the most crucial part of a cadet's tenure and are often mandatory for "B" and "C" certification. Various camps like ATC/CATC: To refresh skills in drill and weapon handling.
- Attachment Training:** Selected cadets are attached to regular Army Naval and Air Force stations.
- Republic Day Camp:** This camp is Held in Delhi every January, culminating in the Prime Minister's Rally.
- Youth Exchange Programme (YEP),** travelling to friendly foreign countries like Russia, Singapore, or the UK to interact with international youth organisations.
- National Integration Camp:** Focuses on bridging cultural gaps between states through shared activities.
- Thal Sainik Camp (TSC):** A competitive camp focusing on Army-specific skills like obstacle courses and shooting.

Benefits of joining NCC

NCC Special Entry Scheme: Holders with an 'A' or 'B' grade are eligible for direct Services Selection Board interviews, skipping the UPSC written exams for the Army, Navy, and Air Force.

Navy: Up to 6 vacancies per course are reserved.

State Services: Many state governments give preference or bonus marks in Police and Forest Department recruitments.

University Admissions: Many Indian universities reserve seats to provide 3–10% weightage in entrance marks for 'C' certificate holders.

Library (Digital access, E-Resources)



Library is a valuable resource for students, researchers and faculties of various programs. The library of each constituent college has built a strong collection of books, current subscription to national and international journals and newspapers, and many other resources like student's project reports, research thesis, CDs, DVDs etc. Considering the importance of computerization of the library, most of the library is automated by using "SOUL" software.



The Central Library of Sarvajani University serves as the academic resource hub for students, faculty, and researchers across all constituent institutes. It provides access to a wide range of print and digital learning materials, ensuring seamless support for teaching, learning, and research activities. The library manages the procurement, cataloguing, and maintenance of its collections while continuously upgrading its services and infrastructure. Efforts are focused on enhancing user experience, expanding digital resources, and promoting an innovative and learner-centric library environment. **Students enrolled with the Sarvajani University can access approximately 3 lac books across all libraries of different constituent units and sister institutions.**



Institution library has a membership of BCIL- Biotechnology Club, INFLIBNET-N-LIST (e-resources) and National Environmental Science Academy. Students get library assignments as per their curriculum. They refer the library books, reference books; journals etc. during this period and get credit as per their credit based curriculum.



All libraries of various constituent colleges are connected online to avail remote access. The students can search any book online using soul webopac book search facility. This can be used from any location than the institute library. Link of this facility is also available on Sarvajani University website.



Generally the constituent colleges organize a book exhibition every year. Books of various subjects and general books for enhancing the reading habit of students are kept for exhibition. There are different sections of Reference books, General Books, Women Empowerment & Competitive Exams. Moreover digital resources from various open sources can be accessed from various institute libraries.

Anti-Ragging policy



The implementation of an anti-ragging policy requires a multi-pronged approach that combines prevention, awareness, monitoring, and strict enforcement of punitive measures, in line with regulations from bodies like the UGC and directives from the Supreme Court of India.



Sarvajanik University maintains a zero-tolerance policy towards ragging in any form, both on and off campus, including in hostels, canteens, and online spaces. Ragging is a criminal offense, and anyone found guilty will face severe disciplinary action, including expulsion and criminal prosecution under the law.



Ragging, as defined by UGC Regulations, includes any act that causes annoyance, hardship, physical or psychological harm, or raises fear in a student, physical or sexual abuse, assault, financial extortion, and verbal abuse. This also covers teasing, treating students rudely, or forcing them to do things that cause shame or embarrassment.



Publicity campaigns with posters and banners, along with providing freshers with policy information, are crucial. Joint orientation programs for freshers and seniors, led by administration and faculty, help promote a respectful environment. Students and parents are required to submit online anti-ragging undertakings annually through designated national websites.



An Anti-Ragging Committee (ARC), headed by the Principal, oversees policy implementation and complaint investigation with representation from various stakeholders. An Anti-Ragging Squad (ARS) conducts surprise checks in vulnerable areas. CCTV surveillance in critical locations and mentoring cells for freshers also contribute to vigilance.

ONLINE ADMISSION PROCESS



Admission for all UG, PG and PG Diploma programs are processed through online mode only. There is no offline form or process for submitting admission details. The aspirants can submit their expression of interest or admission application form by visiting the Sarvajanik University website or scanning the QR code to reach the admission process link.

HOW TO APPLY



Students can submit their admission application form online through Sarvajanik University admission portal at <https://student.sarvajanikuniversity.ac.in:8080/admissionindex.html>. Alternatively the students can access the application form link by scanning QR code placed on sarvajanik university website or admissions 26-27 under admission menu on the university website.

ELIGIBILITY & PROGRAM DETAILS



The eligibility for admission to a particular program and details of colleges are available in the prospectus which is available on <https://sarvajanikuniversity.ac.in>. Students are informed to thoroughly study all the details before starting to submit an online application form for admission.

PROCESSING FEE



The processing fee of Rs. 300 (non refundable) shall have to be paid online via UPI, Net Banking or Debit / Credit cards. Apart from online submission of the application, online payment of fees and online document submission, there is no other option available for submitting admission application form, which please be noted.

REGISTRATION & OTP VERIFICATION



In order to submit an online application form for admission, the student must have a unique mobile number and e-mail ID. The student will get OTP on the mobile number as well as via email during the registration process for admission. Upon successful submission of the correct OTP from mobile or email the student will get an application number starting with AQ followed by a number which the student shall have to keep with them till the completion of the entire admission process.

HELP CENTERS



All constituent colleges of the Sarvajanik University shall function as help centers. In case of confusion in filling the online admission application form or any kind of confusion during the admission process, help centers have to be contacted. On successful submission of the online application form, the aspirants are advised to preserve the admission application number or print of the admission form.

RESERVATION & QUOTA



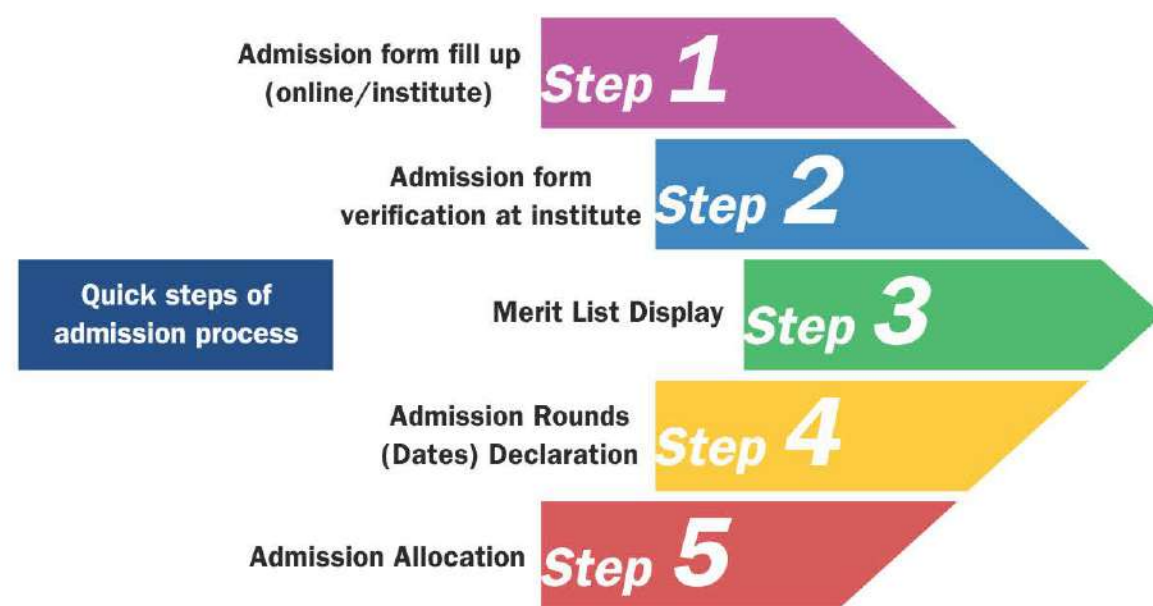
In order to take advantage of admission to any of the reserved category seats, the students shall have to submit the valid certificate required for the concerned category from the competent authority. The reservation shall be for SC, ST, SEBC, EWS, PH, Kashmiri immigrants. Moreover there shall be a separate quota for the students who have passed their 12th examination from GSEB and the students who passed their 12th examination from all other boards. Sports quota seats shall be allocated to the candidates holding certificates of National or State level sports / cultural events. There shall be a separate merit list based on the certificates and physical tests of the aspirants. Admission confirmed under sports quota shall be allotted to the supernumerary seats provided for the said course.

Admission Process

Sarvajanik University shall upload details of all programs offered at constituent colleges along with eligibility for admission and will float a form for all aspiring students, namely Expression of Interest (EOI). The students will fill up all relevant data as asked and submit EOI to Sarvajanik University. These EOI shall be available to all aspiring students and the public at large through a link provided on Sarvajanik University's website and all constituent Colleges' websites.

It it requires then the constituent college shall further contact these aspiring students through email, SMS, phone call or any other possible way and guide / counsel them and also resolve their doubts. Aspirants can submit their details, upload relevant documents and pay admission application fee online using ERP portal. For students who have already applied and submitted EOI; their data shall be directly fetched by ERP and after entering pending details, the student will submit the application forms for admission. Next step is to verify the admission application form. For verification of admission application form the aspirant requires to visit any of the constituent colleges with all original documents and a set of its xerox copy. The constituent college staff shall verify the admission application form and generate print after successful verification. The university and its constituent colleges will put up a detailed schedule of admission rounds and the admission procedure as per norms laid by Sarvajanik University. Admissions shall be done with fair means and transparency. After declaring the merit list, the entire admission process shall be done through ERP. Steps of this process is as mentioned below:

- Submission of admission application form by aspirants.
- Document verification
- Declaration of merit list
- Allocation of admission as per the choice of students through multiple rounds
- Allotment of admission letter and fee payment
- Course/program-wise orientation program at Sarvajanik University
- Issue unique enrolment number to each admitted student



Documents required: Marksheets of relevant educational qualification, Aadhar card, leaving certificate or transfer certificate and a passport photo is required. Moreover, if the student belongs to a specific category then scan a copy of the relevant cast / category document is required to be submitted with the admission application form. For confirming the admission in sports quota, relevant sport achievement certificate(s) are required.

The admission form can also be filled using GCAS (Gujarat Common Admission Services) portal for many courses offered by the Sarvajanik University.
